Expansion Issues Across Multi-Site Child Care Operators In Ontario

Summary

The Survey

- The survey was conducted in late 2024 by Building Blocks for Child Care (B2C2).
- This is a report on results from 52 multi-site child care operators. The report on stand-alone centres will follow.
- The main purposes were to assess actual expansion since the federally-funded CWELCC program began (2022 in Ontario), the intentions for future expansion, and the barriers/supports affecting growth.

The Results

The survey results reveal a clear and urgent truth: Ontario's multi-site child care operators are interested in expansion and willing to expand, yet their ability to do so is constrained by persistent, systemic barriers. While the CWELCC program has lowered parent fees, increased demand, and sparked some growth since 2022, expansion remains uneven. As our survey results show, non-profit multi-site child care providers face ongoing staffing shortages and financial uncertainty. For-profit multi-site providers identified inconsistent access to CWELCC participation and funding as major barriers to their expansion as of late 2024.

The most pressing obstacles—staff recruitment and retention, secure and adequate operating funding for new services, and lack of grant or loan funding for capital investment—are not insurmountable, but they require government actions and supports, especially to facilitate non-profit expansion. Operators have demonstrated initiative, with most already taking concrete steps toward expansion, yet without adequate and guaranteed future operational funding, robust workforce strategies, and meaningful capital support, these plans risk stalling.

If Ontario is to meet the urgent demand for affordable, high-quality, predominantly non-profit and public child care, governments at all levels must act now. That means:

- Guaranteeing future operational funding that fully covers the costs of expansion and ongoing delivery.
- Investing in the workforce through competitive wages, benefits, and long-term retention strategies for all early childhood educators.
- Providing capital grants, loan guarantees, and access to municipal or school board space to lower the barriers to building or retrofitting facilities.
- Our survey results say that multi-site operators have the interest, commitment, and readiness to deliver child care spaces that families need. The question is whether the policy and funding environment will empower them, and the children and families that depend on them, to succeed.

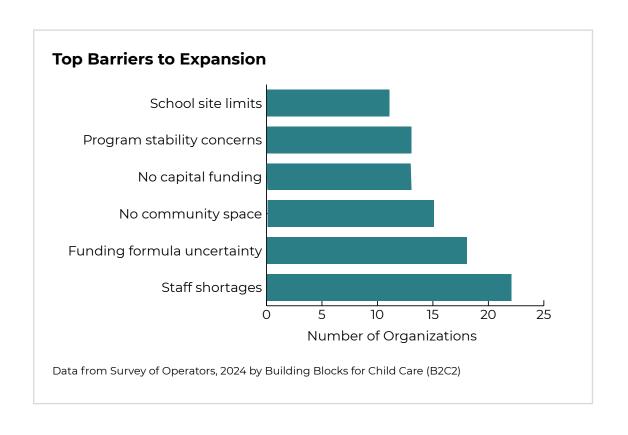

Expansion Interest

Most multi-site organizations expressed an interest in expansion (64% interested, 25% unsure, 12% with no interest). Among those interested or unsure, nearly 78% are likely or very likely to expand within the next five years. Planned expansions are mostly for 1-99 spaces, though some for-profits plan >500 spaces.

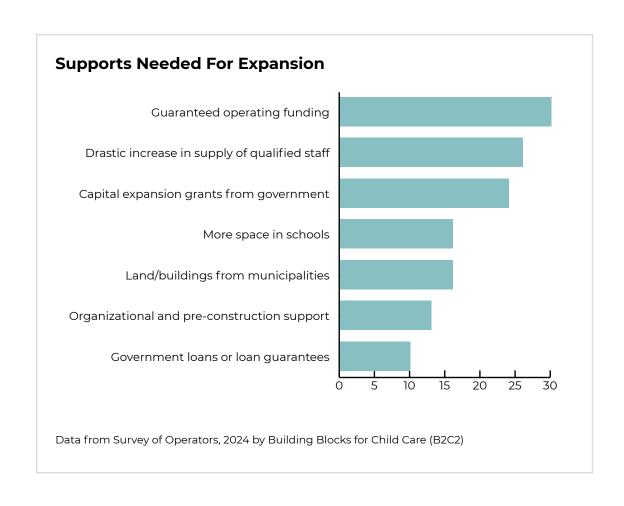
Barriers to Expansion

Over 70% of multi-site operators reported barriers to expansion. Most frequently cited were staffing shortages (22 organizations), insecure funding formula (18), and lack of capital funding (13). Other notable barriers included a lack of community space for expansion and concern about program stability. Note that this survey was conducted shortly before the new operational funding formula was implemented in January 2025.



Supports Needed for Expansion

Operators identified several supports needed for expansion: guaranteed operating funding (30 organizations), increased qualified staff supply (26), capital grants (24), and access to land or buildings through municipalities and space in schools (16 each).



Financial Health Since 2022 in Ontario

Financial outcomes are mixed. Across the sector close to one-quarter report better financial health, one-quarter report worse financial health and about half report that things are about the same. However, the pattern is different for non-profits vs. for-profits. About 19% of non-profit multisite operators reported improved financial health compared to 44% of for-profit multi-sites. Roughly 25% of the non-profit organizations and 33% of the for-profits reported declines in financial health. About 56% of non-profits reported that their financial health was stable, while this was true for only about 22% of for-profit multisite operators.

Staffing

Staff shortages are a pressing issue. Of the respondents to one question, about 52% of non-profits said staff shortages have forced them to reduce capacity, compared to none of the for-profits.

Voices from a Range of Operators

Concerns raised to the Minister of Education:

- Wage levels and fairness across centres.
- Stability and transparency of CWELCC funding.
- Need for more expansion support, especially for infants and school-age children.
- Calls for inclusion of for-profits in CWELCC supports.
- Access to land and municipal space.

Retention/recruitment initiatives:

- Higher wages, benefit enhancements, pensions, staff wellness initiatives, flexible work schedules.
- Some cannot afford raises under current funding rules.

Policy Needs:

- Stability of CWELCC beyond 2026.
- Transparent, fair funding formula.
- Wage grid for educators across the sector.
- Greater access to capital funding and municipal land.
- Expanded supports for staff recruitment and retention.

Conclusions

Multi-site operators are keen to expand and many already have, but face serious barriers: Amongst the most serious are staffing shortages, uncertainties of operating funding going forward and lack of provision of capital grants and loans.

While CWELCC has enabled some growth, expansion is uneven—non-profits struggle more with staffing and finances, while for-profits are concerned about CWELCC participation and funding-access issues. Operators seek stronger government support, guaranteed operational funding that covers costs of new centres, and workforce strategies to make expansion sustainable.

Report on Survey of Multi-Site Operators

This survey was conducted in late 2024. Child Care operators across the province were asked to fill out a lengthy online survey about actual recent expansion of capacity and intentions and barriers to expansion. Of the respondents, 134 were operators or directors of standalone centres, 52 were directors, CEOs, or owners of multi-site child care operations. There was another group of multi-site operators who were asked to fill in a simpler version of the survey as part of a test of the questionnaire. For relevant questions that were similar across the earlier and later versions of the questionnaire, we include the respondents to the test questionnaire in the tabulated results.

This report tabulates and analyzes results for Multi-Site operators only. A second report will tabulate and analyze results for stand-alone centres.

The overall story for multi-site operators is a positive one with qualifications. Multi-site child care operations in Ontario are willing and anxious to expand the supply of child care services. Many have already done so and want to do more. However, the road to expansion is rough, with potholes and barriers. We can learn a great deal from what these operators say about the barriers to expansion.

Auspice

About 77% of the multi-site respondents were not-for-profits, with most of the rest being for-profits. Because there is only one public sector child care multi-site organization in the survey responses, we usually include the results for this organization with non-profit responses..

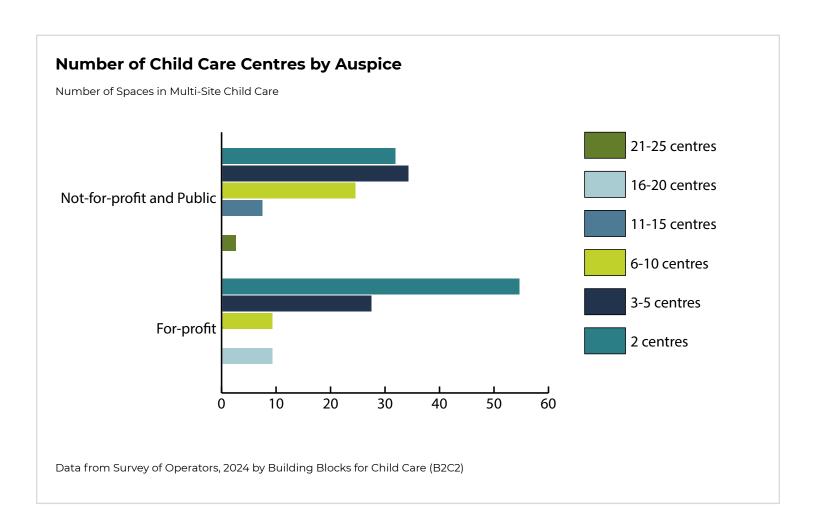

Size (Number Of Centres)

Many of these multi-site groups (36 of 52) operate 5 centres or fewer. Others operate larger numbers of centres as the table below shows. This is not entirely representative of the population of multi-site centres in Ontario as there are a number of much larger multi-site operations, especially non-profits. Some of these were excluded from answering the final version of the survey because they had already helped us by answering the pilot version.

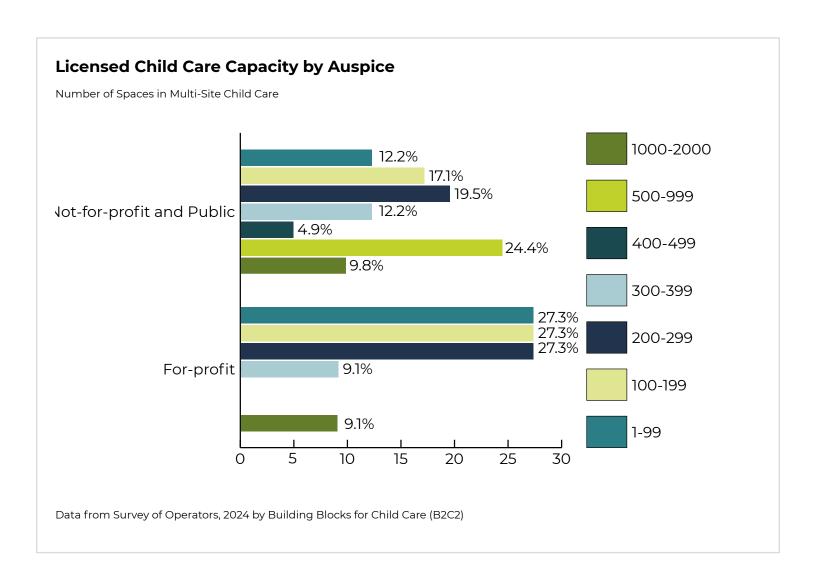

Size (Total Licensed Capacity Of Multi-Site Groups)

Many of these multi-site groups have substantial numbers of licensed spaces. For example 34 out of the 52 respondents have licensed capacity of 200 spaces or greater. 15 have licensed capacity of 500 spaces or more.

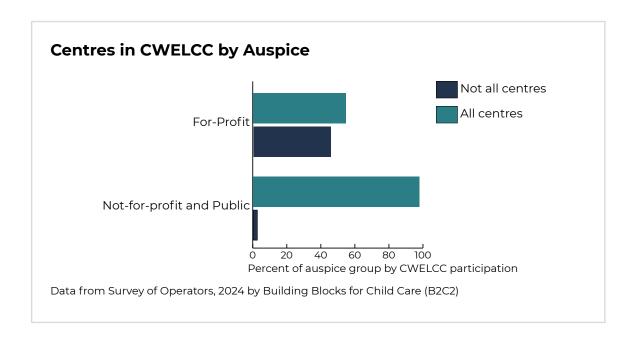


Total licensed capacity of multi-site child care groups, Ontario, 2024

Participation in the \$10 a day program (CWELCC)

The large majority of the multi-site respondents to the survey have all of their centres participating in the \$10 a day (Canada-Wide Early Learning and Child Care or CWELCC) program. Only 6 of the multi-site groups do not. 5 of these are for-profit operations. Even for these "non-participants", the majority have some of their centres, but not all, who are participating in CWELCC.

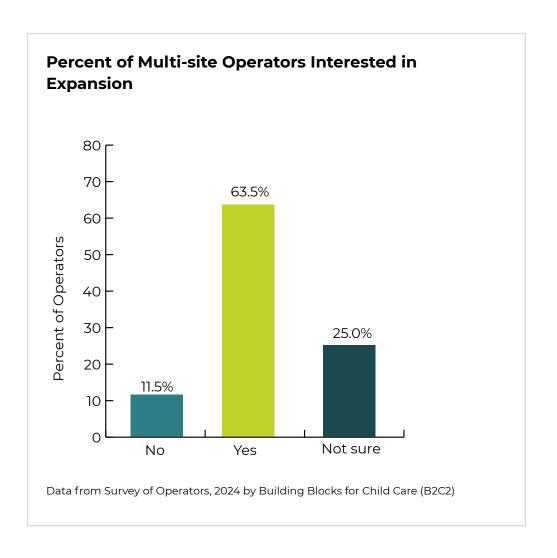
Interest in expansion

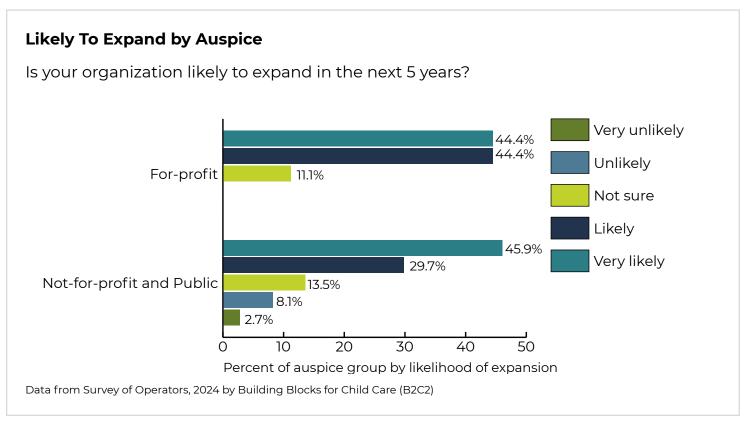
Most multi-site organizations declare that they are interested in pursuing expansion (about 64%) and that is true for non-profits and for-profits alike. And most other groups are unsure about expansion, rather than opposed. Only about 12% of respondents indicated opposition.

Respondents who said yes or unsure to the expansion question (46 respondents) were then asked whether their organization was likely to expand the number of spaces or set up new centres within the next five years. 36 out of 46 (or over 78%) said they were likely or very likely to expand in this period. Only 4 said no, and the rest were unsure.

Actual and planned expansion

Of the 42 multi-site organizations who indicated likelihood of expansion in the next 5 years, or being unsure about near-term expansion, 28 have already added spaces for children 0-5 years of age since CWELCC started in Ontario in 2022. In most cases, 20 organizations, this expansion has been less than 100 spaces, with 8 organizations adding 100 spaces or more (4 non-profit and 4 for-profit).

When asked how big the planned expansion would be, 13 groups said between 1 and 49 spaces and another 6 multi-site organizations said between 50 and 99 spaces. 7 organizations plan expansion between 100 and 500 spaces and 2 over 500 spaces. Expansions over 500 spaces are in for-profit multi-site groups.

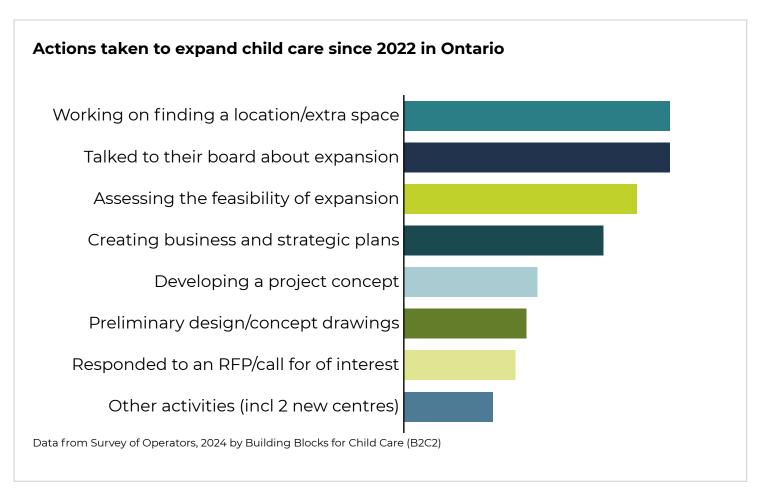

State of expansion actions

The majority of those organizations likely to expand or unsure have taken concrete actions necessary for expansion to take place. That's true of 34 out of 46 organizations or about 74%.

Organizations who are engaged in expansion were asked what specific actions towards expansion that they had taken since 2022.

- 24 said they had talked to their board about expansion
- 21 said they were assessing the feasibility of expansion
- 24 said they were working on finding a location/finding extra space
- 18 said they were creating business and strategic plans
- 12 said they had been developing a project concept
- 11 said they had worked on preliminary design/concept drawings
- 4 had issued an rfp for an architect
- 10 had responded to an rfp or call for expression of interest
- 8 had engaged in other activities related to expansion, including 2 that had opened new centres.

The next set of questions have answers that are difficult to summarize. Because these multi-site organizations can be large and may have a number of projects on the go, respondents were asked questions about up to 10 possible projects. For instance, multi-site organizations were asked the expansion methods that were or are being implemented on the different projects since 2022. The possible answers were renovation/retrofit, new build, or expand into licensable space.

It appears that there are at least 7 multi-site groupings with at least 7 projects on the go and 1 with 10 projects. There are quite a few with 1, 2 or 3 projects on the go.

This is one of a number of questions that refer to up to 10 possible projects that a multi-site group might have been engaging in since 2022. These questions are:

- What is the status of the new expansion property for each of these projects? (7)
- Do you have CWELCC operational funding already confirmed for each of these projects? (7)
- What stage is each project at (a question with 12 possible answers for each of the projects)? (7)
- When do you anticipate starting construction for each of these projects? (4)
- When do you anticipate finishing construction for each of these projects? (4)

Although the first question had one multi-site group providing information about 10 projects, the subsequent questions provided answers for fewer projects. The numbers in parentheses indicate the maximum number of projects listed in answer to each question.

Financing expansion

Nine multi-site organizations responding to the survey are seeking funding for capital expansion. Another 17 are not looking for financing (or not yet). One group indicated that it already had financing. That makes 27 respondents in total; i'm not clear why more did not answer this question. had opened new centres.

The multi-site group that has already found financing indicated that the amount was \$100,000 or less. It was a for-profit group so it's likely there was internal financing provided by the owners as well.

The multi-site group that did find financing was asked about the source. Options included

- Ministry of education start-up funding
- Loan from a bank or other financial institution
- Angel investor
- Municipality provided extra funding (in addition to start-up)
- Other

This respondent indicated "other" and that the financing came from "personal funds".

Multi-site operators were asked how much money they were seeking in order to expand services. Of the 9 organizations that were seeking funding, 6 indicated they were looking for (additional) financing of \$100,000 to \$500,000. One indicated the need for \$500,000 to \$1,000,000. One more indicated the need for between \$1,000,000 and \$2,000,000, and one more indicated the need for between \$2,000,000 and \$5,000,000. Seven of the nine needing financing are non-profit multi-site organizations.

Multi-site organizations were asked what loans – borrowed money – would be used for. One said to purchase land and a building, one said for construction costs on a new building. Eight more said that loan capital would be used for retrofit and renovation costs.

Multi-site organizations were asked about the barriers they had faced in the last 2 years that had impacted their ability to expand. A list of possible barriers was included:

- No capital funding/ no access to government or bank loans
- Lack of a funding formula that has made it too insecure to contemplate expansion
- Not enough qualified staff
- No physical space available in the community
- Worry that future governments might cancel the program
- Centre is in a school building with no capacity for expansion
- Other

Respondents were invited to check all of the possible barriers that applied to them.

At the time that this questionnaire was administered, there was no funding formula guaranteeing future revenues in Ontario, although one had been announced for the future. That did not happen until january of 2025.

Nearly 30% of multi-site organizations did not list any barriers to expansion. The remaining organizations (over 70%) identified between one and six barriers to expansion.

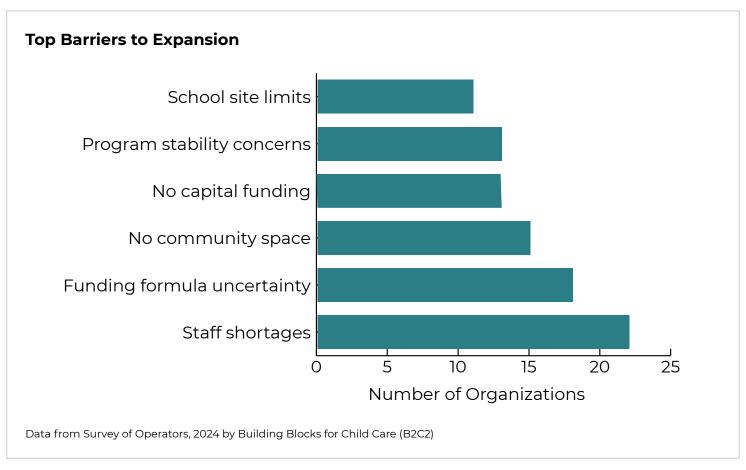

Supports

Multi-site organizations were asked about the supports that are still needed to achieve expansion goals. A list of possible supports was included:

- Capital expansion grants from government
- Organizational and pre-construction support
- Government loans or loan guarantees to make it possible to borrow from banks
- Drastic increase in supply of qualified staff
- More space to be made available in schools
- Land and buildings to be made available by municipalities
- Guaranteed operating funding
- Other

Respondents were invited to check all of the possible barriers that applied to them.

Almost half the respondents indicated no supports were available. Others mentioned between one and four types of support aiding expansion.

Supports still needed

Multi-site organizations were asked about the supports that are still needed to achieve expansion goals. A list of possible supports was included:

- Capital expansion grants from government
- Organizational and pre-construction support
- Government loans or loan guarantees to make it possible to borrow from banks
- Drastic increase in supply of qualified staff
- More space to be made available in schoolsLand and buildings to be made available by municipalities
- Guaranteed operating funding
- Other

Respondents were invited to check all of the possible barriers that applied to them.

About 31% of respondents indicated no need for additional supports to facilitate expansion, but many respondents need several types of support. More than 50% of respondents indicated that 3 or more of the supports listed were important for their organization to be able to expand.

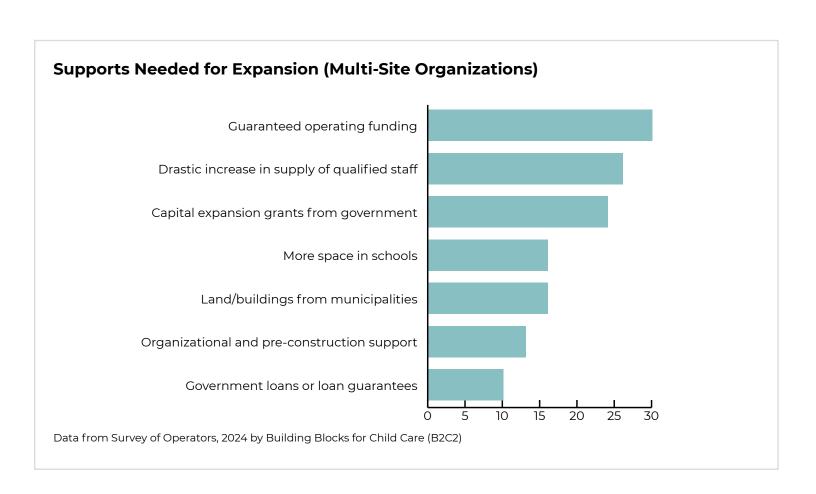

Financial health of multi-site child care organizations

Multi-site organizations were asked how the financial health of their organization had changed since CWELCC began in Ontario in 2022. About 19% of the non-profit respondents said their overall financial health had improved compared to about 44% of for-profit organizations. On the other hand, 25% of non-profit organizations say their overall financial health has declined, compared to 33% of for-profits. The majority of non-profits (56%) say their financial health is about the same, whereas that is only true for 22% of the for-profit organizations.

Expansion has been taking place. Most organizations, whether non-profit or for-profit indicated that they have more qualified staff than they did in 2022 – over 50% of these multi-site organizations in each case. About 24% of non-profits indicate that they have fewer qualified staff now.

Another question asked whether staff shortages had resulted in reduced capacity or had necessitated the closure of rooms. 100% of the for-profit organizations indicated that they did not have staff shortages. But, just over half of non-profits have staff shortages, while just under half do not.

Still on staffing, these multi-site organizations were asked whether, in any of their centres, they had more RECEs than required by regulations. A large majority of respondents (about 70%) answered yes. This was the case for 83% of for-profit organizations and 65% of non-profit multi-site organizations.

No respondents indicated a need to rely on director's approvals in order to meet the required staffing standards in their centres.

Conclusion

The survey results reveal a clear and urgent truth: Ontario's multi-site child care operators are interested in expansion and willing to expand, yet their ability to do so is constrained by persistent, systemic barriers. While the CWELCC program has lowered parent fees, increased demand, and sparked some growth since 2022, expansion remains uneven. As our survey results show, non-profit multi-site child care providers face ongoing staffing shortages and financial uncertainty. For-profit multi-site providers identified inconsistent access to CWELCC participation and funding as major barriers to their expansion as of late 2024.

The most pressing obstacles—staff recruitment and retention, secure and adequate operating funding for new services, and lack of grant or loan funding for capital investment—are not insurmountable, but they require government actions and supports, especially to facilitate non-profit expansion. Operators have demonstrated initiative, with most already taking concrete steps toward expansion, yet without adequate and guaranteed future operational funding, robust workforce strategies, and meaningful capital support, these plans risk stalling.

If Ontario is to meet the urgent demand for affordable, high-quality predominantly non-profit and public child care, governments at all levels must act now. That means:

- **Guaranteeing future operational funding** that fully covers the costs of expansion and ongoing delivery.
- **Investing in the workforce** through competitive wages, benefits, and long-term retention strategies for all early childhood educators.
- Providing capital grants, loan guarantees, and access to municipal or school board space to lower the barriers to building or retrofitting facilities.

Our survey results say that multi-site operators have the interest, commitment, and readiness to deliver child care spaces that families need. The question is whether the policy and funding environment will empower them, and the children and families that depend on them, to succeed.
